Most of the WTO's agreements were the outcome of the 1986-94 Uruguay Round of trade negotiations. Some, including GATT 1994, were revisions of texts that previously existed under GATT as multilateral or plurilateral agreements. Some, such as GATS, were new. The full package of multilateral Uruguay Round agreements is called the round's Final Act.

Most of the WTO agreements are the result of the 1986-94 Uruguay Round negotiations, signed at the Marrakesh ministerial meeting in April 1994. There are about 60 agreements and decisions totalling 550 pages. Negotiations since then have produced additional legal texts such as the Information Technology Agreement, services and accession protocols. New negotiations were launched at the Doha Ministerial Conference in November 2001.

The Uruguay Round of multilateral trade negotiations produced the Marrakesh Agreement Establishing the World Trade Organization, which governs the institutional operations of the WTO. The Marrakesh Agreement includes four annexes. Collectively, the Marrakesh Agreement and its annexes are sometimes referred to as the WTO's founding agreements.
